1. Eligibility

- Scholarships are open to new boarding applicants entering Year 9, 10, 11, 12 or 13.
- Applicants must complete **both** a scholarship application form **and** a St David's College **registration form** and submit along with a school report and evidence of their achievements and abilities relating to the scholarship category under which they are applying.
- Current pupils of St David's College are not eligible for this scholarship.
- Scholarship applications must be submitted **simultaneously** with new registration forms in order to be considered.
- Candidates with **existing applications or offers in process are not eligible** for this scholarship.

2. Scholarship Award

- Each scholarship provides a **10% discount** on boarding fees for the **duration** of the student's enrolment at St David's College.
- A maximum of **twelve scholarships** will be awarded per year, over a period of **five** years.
- The school reserves the right not to award the maximum number of scholarships in a given year.

3. Categories of Excellence

Scholarships will be awarded in recognition of excellence in the following areas:

- Academic excellence
- Sport and athletic achievement
- Music and performing arts
- Art and design
- Leadership in outdoor education
- Community leadership and service
- Overcoming barriers to learning

4. Application and Selection

- Only complete applications received by the published deadline will be considered.
- Candidates will be shortlisted by a **panel** including the Senior Leadership Team and Admissions Team.
- Shortlisted candidates will be assessed by members of the **Senior Leadership Team** and/or **Head of Department** relevant to their chosen scholarship category.
- The selection panel reserves the right to determine the number and distribution of scholarships across categories.

5. Notification and Acceptance

- Successful applicants will be notified in writing and must confirm **acceptance of both the scholarship and their school place** within a designated timeframe.
- Failure to confirm acceptance within this timeframe may result in the withdrawal of the scholarship offer.

6. Conditions of Tenure

- Scholars must demonstrate **consistent effort, engagement, and conduct** aligned with the values of St David's College.
- Continued receipt of the scholarship is subject to **annual review**.
- The school reserves the right to **withdraw the scholarship** if the student fails to uphold expected standards.
- Scholarship recipients should be aware that they will be asked to take part in reasonable promotional activities such as photography, video, interviews, and case studies. Participation will always be discussed in advance and handled with sensitivity, and any materials produced may be used in school publications, marketing materials, and digital channels to help promote the scholarship programme and the school more broadly.

7. General Terms

- Scholarships are **non-transferable** and have **no cash value**.
- A scholarship award **does not cover additional costs** such as uniforms, trips, or exam fees.
- St David's College reserves the right to **amend or withdraw** the scholarship scheme at its discretion.
- Decisions made by the scholarship panel are final and not subject to appeal.
- The total of all awards made on scholarship day must not exceed the total value stated by the Bursar.

- The last year of entry for which applications for this scholarship can be considered is September 2029.
- The award of academic scholarships is at the absolute discretion of St David's College.

8. Equality
